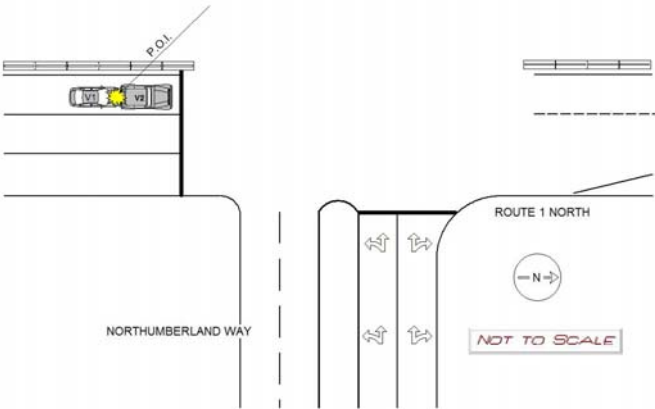

DRIVER #1 STATED, HE STARTED TO MOVING AFTER THE LIGHT CHANGE AND CRASHED INTO THE REAR BUMPER OF VEHICLE #2 WHEN SHE WAS STOPPED.

DRIVER #2 STATED, SHE WAS STOPPED IN TRAFFIC IN WHEN VEHICLE #1 CRASHED INTO HER REAR BUMPER.

WHILE ON SCENE NO ONE COMPLAINED OF PAIN OR REQUESTED MEDICAL ATTENTION .

I OBSERVED DISABLING DAMAGE TO THE FRONT BUMPER AREA OF VEHICLE #1 AND MODERATE DAMAGE TO THE REAR BUMPER OF VEHICLE 2.
