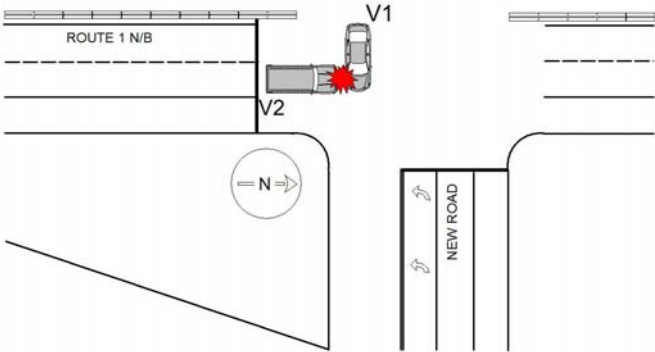
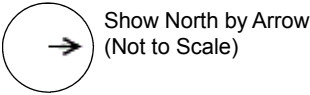

D1 STATED THAT SHE WAS PROCEEDING EAST ON NEW ROAD IN THE AREA OF THE TACO BELL RESTAURANT APPROACHING US HIGHWAY 1. SHE STATED SHE OBSERVED THAT THE TRAFFIC SIGNAL WAS YELLOW SO SHE PROCEEDED THROUGH THE INTERSECTION. SHE THEN STATED THAT V2 STRUCK HER. D2 STATED THAT HE WAS PROCEEDING NORTH ON ROUTE 1 AND HE OBSERVED THAT THE TRAFFIC SIGNAL WAS GREEN. HE THEN STATED THAT HE WAS STRUCK BY V1 AS HE ENTERED THE INTERSECTION. THE PASSENGER IN V2 SAID THAT HIS VEHICLE WAS PROCEEDING NORTH ON ROUTE 1 APPROACHING THE INTERSECTION OF NEW ROAD. HE SAID THAT THE TRAFFIC SIGNAL WAS GREEN AND HAD BEEN GREEN FOR SEVERAL SECONDS. THE PASSENGER THEN STATED THAT V2 WAS STRUCK BY V1 WHICH WAS PROCEEDING EAST ON NEW ROAD ACROSS THE INTERSECTION. THE PASSENGER IN V1 WAS UNABLE TO PROVIDE A STATEMENT DUE TO HER INJURIES. D1 WAS COMPLAINING OF PAIN IN HER LEGS AND LOWER BODY AND WAS TRANSPORTED TO PRINCETON MEDICAL CENTER BY SOUTH BRUNSWICK EMS. THE PASSENGER IN V1 HAD SEVERAL FACIAL LACERATIONS AND A POSSIBLE BROKEN NOSE AND WAS TRANSPORTED TO PRINCETON MEDICAL CENTER BY SOUTH BRUNSWICK EMS. V1 HAD SEVERE DAMAGE TO THE RIGHT FRONT SIDE AND FRONT END. V2 HAD SEVERE FRONT END DAMAGE. MY INVESTIGATION REVEALED THAT THE COLLISION WAS CAUSED BY D1 WHEN SHE FAILED TO STOP AT THE TRAFFIC SIGNAL.
