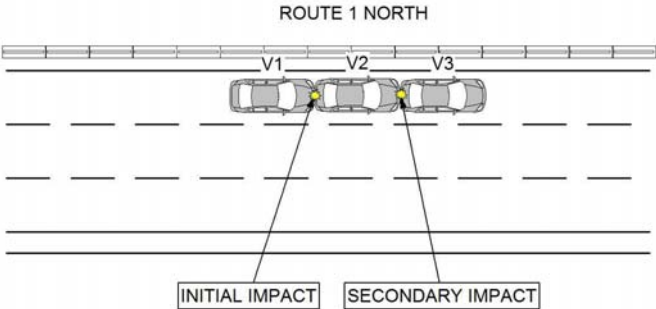

V1 LEFT PRIOR TO POLICE ARRIVAL. D1 EXCHANGED INSURANCE INFORMATION WITH D2 AND D3.

D2 STATED IN EFFECT THAT V2 WAS STOPPED IN TRAFFIC ON ROUTE ONE NORTH. D2 FURTHER STATED THAT V1 STRUCK THE REAR BUMPER OF V2 AND THAT V2 WAS PUSHED FORWARD BY V1. V2 SUBSEQUENTLY STRUCK THE REAR BUMPER OF V3.

D3 STATED IN EFFECT THAT V3 WAS STOPPED IN TRAFFIC ON ROUTE ONE NORTH. D3 FURTHER STATED THAT V2 STRUCK THE REAR BUMPER OF V3.

INVESTIGATION DETERMINED D1 TO BE AT FAULT FOR THE ACCIDENT.
