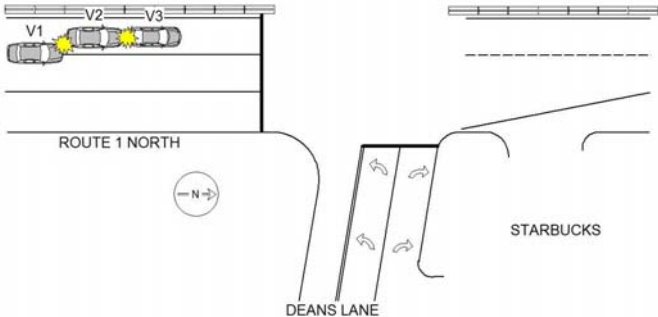

145 Crash Description

DRIVER 1 STATED HE WAS TRAVELING NORTH ON ROUTE 1, IN THE LEFT LANE, WHEN HE FAILED TO OBSERVE VEHICLE 2 AND 3 STOPPING IN FRONT OF HIM. THEREFORE THE FRONT OF HIS VEHICLE COLLIDED WITH THE REAR OF VEHICLE 2.

DRIVER 2 STATED HE WAS TRAVELING NORTH ON ROUTE 1, IN THE LEFT LANE, WHEN HE BEGAN TO APPLY HIS VEHICLE'S BRAKES DUE TO HEAVY TRAFFIC CONDITIONS AND THE PRESENCE OF A MARKED PATROL UNIT IN THE AREA. IT WAS AT THIS TIME THAT HE FELT THE IMPACT OF VEHICLE 1 COLLIDING WITH THE REAR OF HIS VEHICLE.

DRIVER 3 ALSO STATED THAT SHE WAS TRAVELING NORTH ON ROUTE 1, IN THE LEFT LANE, WHEN SHE BEGAN TO APPLY HER VEHICLE'S BRAKES DUE TO HEAVY TRAFFIC CONDITIONS AND THE PRESENCE OF A MARKED PATROL UNIT IN THE AREA. IT WAS AT THIS TIME THAT SHE FELT THE IMPACT OF VEHICLE 2 COLLIDING WITH THE REAR OF HER VEHICLE.

INVESTIGATION DETERMINED DRIVER 1 TO BE AT FAULT FOR FOLLOWING TOO CLOSELY FOR THE TRAFFIC CONDITIONS.
