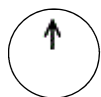


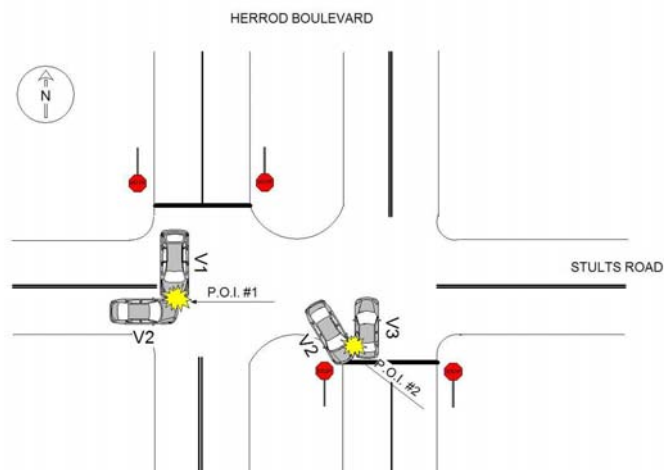

145 Crash Description

D1 STATED, IN EFFECT, THAT HE WAS STOPPED ON HERROD BLVD SOUTHBOUND AT THE INTERSECTION WITH STULTS ROAD. D1 SAID HE PROCEEDED THROUGH THE INTERSECTION AND COLLIDED WITH V2, WHICH WAS GOING EASTBOUND ON STULTS ROAD. WHEN ASKED WHY HE PROCEEDED THROUGH THE INTERSECTION, D1 ADMITTED THAT HE DID NOT HAVE THE RIGHT OF WAY BUT SAID V2 WAS "COMING TOO FAST." D2 STATED, IN EFFECT, THAT SHE WAS GOING EASTBOUND ON STULTS ROAD WHEN V1 ENTERED THE INTERSECTION FROM HERROD BLVD. SOUTHBOUND AND STRUCK HER VEHICLE. D2 SAID SHE WAS THEN PROPELLED INTO V3. D3 STATED, IN EFFECT, THAT HE WAS STOPPED ON HERROD BLVD. NORTHBOUND WHEN HE OBSERVED V1 ENTER THE INTERSECTION FROM HERROD BLVD. SOUTHBOUND, COLLIDE WITH V2, AND THEN V2 WAS PROPELLED INTO HIS VEHICLE. D1 AT FAULT.

THERE WERE A TOTAL OF FIVE INJURIES REPORTED AT THE SCENE. D1 COMPLAINED OF CHEST PAIN DUE TO HIS SEAT BELT AND WAS TRANSPORTED TO ROBERT WOOD JOHNSON [RWJ] BY SOUTH BRUNSWICK EMS (#A58). D2 COMPLAINED OF KNEE PAIN AND CHEST PAIN AND WAS TRANSPORTED TO RWJ BY KENDALL PARK FIRST AID SQUAD (#A59). THE FRONT SEAT PASSENGER IN V1 COMPLAINED OF SHOULDER PAIN AND WAS TRANSPORTED TO RWJ BY #A59. A PASSENGER IN THE SECOND ROW OF V1 COMPLAINED OF NECK PAIN WAS TRANSPORTED TO RWJ BY #A58. ANOTHER SECOND-ROW PASSENGER IN V1 COMPLAINED OF HEAD PAIN, WAS EVALUATED AT THE SCENE BUT REFUSED TRANSPORT TO THE HOSPITAL.

IT SHOULD BE NOTED THAT V1 WAS BEING UTILIZED AS A BUS AND CONTAINED FOUR, THREE-PERSON ROWS OF PASSENGER SEATS BEHIND THE DRIVER AND FRONT-PASSENGER SEATS. THUS, SOME OCCUPANTS' POSITION IN THE VEHICLE (BOX #84) WAS LISTED AS "BUS SEATING."
