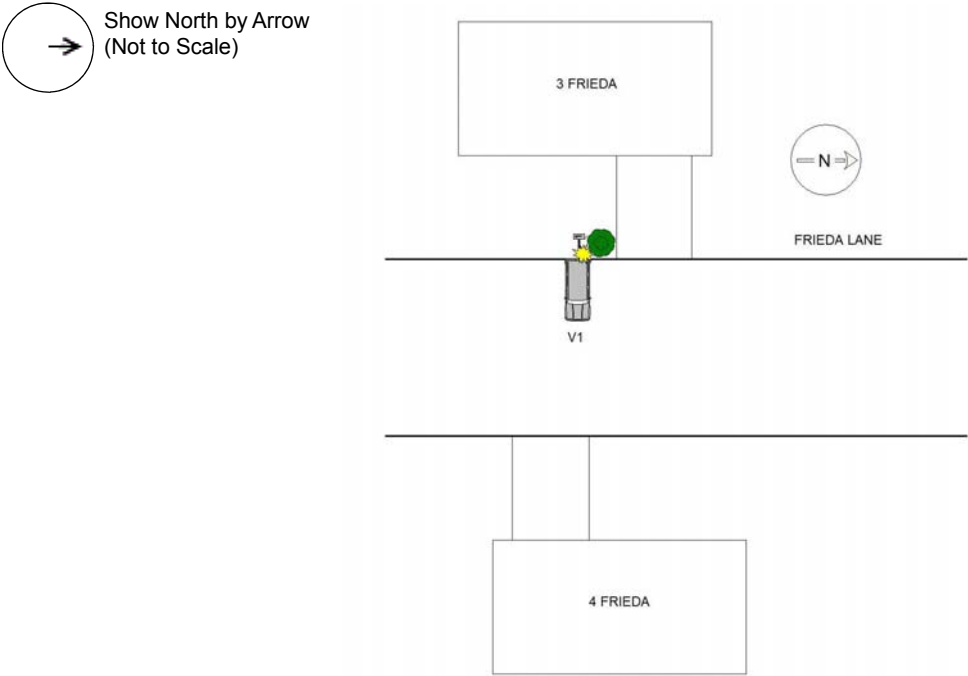

CRASH REPORTED BY HOMEOWNER OF 3 FRIEDA LANE, LOIS FOLEY. FOLEY STATED HER NEIGHBOR, D1, BACKED INTO HER TREE AND MAILBOX NEXT TO HER DRIVEWAY DAMAGING BOX. SHE STATED D1 HAD A FAMILY EMERGENCY AND COULD NOT STAY ON SCENE.

MADE CONTACT WITH D1 VIA TELEPHONE AND RESPONDED BACK TO RESIDENCE LATER IN EVENING TO GATHER FURTHER INFORMATION. D1 STATED IN SUMMARY THERE WAS A FAMILY EMERGENCY AND AS SHE WAS BACKING OUT OF HER DRIVEWAY HER FOOT GOT CAUGHT ON THE GAS PEDAL. D1 STATED THIS CAUSED HER VEHICLE TO IMPACT HER NEIGHBOR'S MAILBOX AND TREE.
