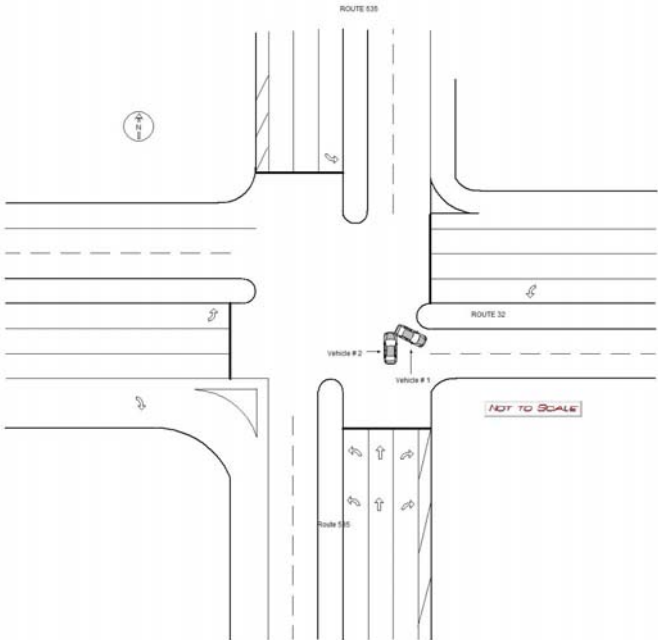
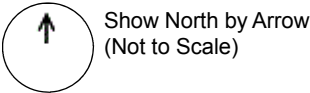

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT SHE WAS MAKING A LEFT FROM ROUTE 535 ONTO ROUTE 32 AND WAS STRUCK BY VEHICLE # 2.

DRIVER OF VEHICLE # 2 STATED IN EFFECT THAT SHE WAS TRAVELING NORTH ON ROUTE 535 WHEN VEHICLE # 1 TURNED LEFT IN FRONT OF HER AND THEY CRASHED.

OFFICER INVESTIGATION DETERMINED VEHICLE # 1 TO BE AT FAULT FOR THE CRASH.

BOTH VEHICLES WERE DRIVEABLE, MOVED PRIOR TO POLICE ARRIVAL.
