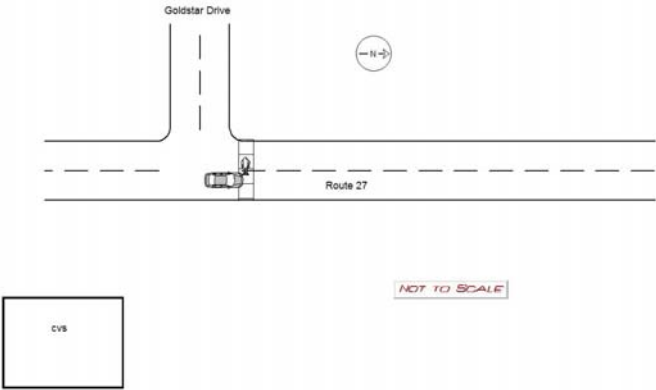
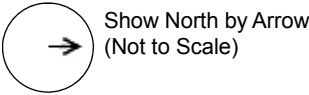

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT HE WAS TRAVELING NORTH ON ROUTE 27, DIDN'T SEE THE PEDESTRIAN UNTIL IT WAS TOO LATE TO STOP. HE CONTINUED WITH STATING " HE CAME OUT OF NOWHERE".

PEDESTRIAN STATED THAT HE WAS HEADING TO THE CVS STORE. HE WAS CROSSING ROUTE 27 IN THE CROSSWALK ON HIS SKATEBOARD, HE PUT HIS HAND UP HOPING THE VEHICLE WOULD STOP BUT IT DIDN'T.
