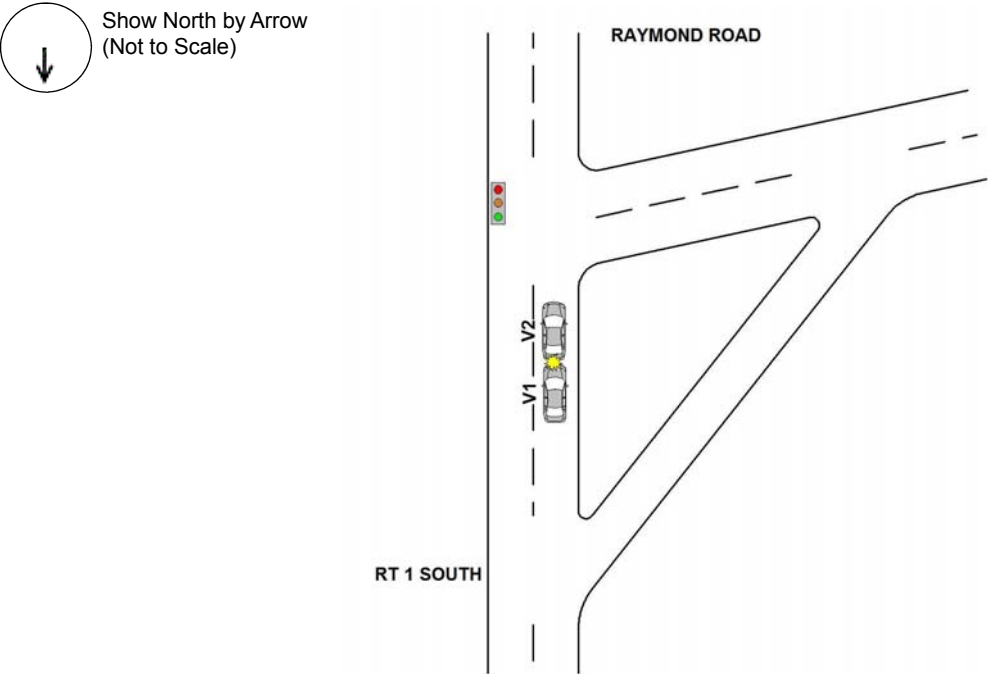

V1 STRUCK V2 IN THE REAR ON RT 1.

D2 STATED IN EFFECT HE WAS STOPPED AT THE LIGHT ON RT 1 SOUTH WHEN HE WAS STRUCK FROM BEHIND BY D1.

D1 STATED IN EFFECT SHE OBSERVED D2 STOPPED AT THE TRAFFIC LIGHT, TRIED TO SLOW DOWN BUT COULD NOT IN TIME AND STRUCK D2 IN THE REAR.

D2 HAS A VALID MEXICO DRIVERS LICENSE AND IS IN THE PROCESS OF GETTING A PENNSYLVANIA ONE.
