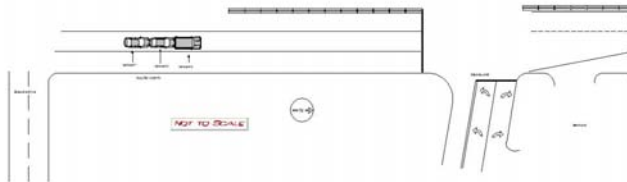

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT TRAFFIC STOPPED SHORT IN FRONT OF HIM AND HE WAS UNABLE TO STOP BEFORE CRASHING INTO VEHICLE # 2.
