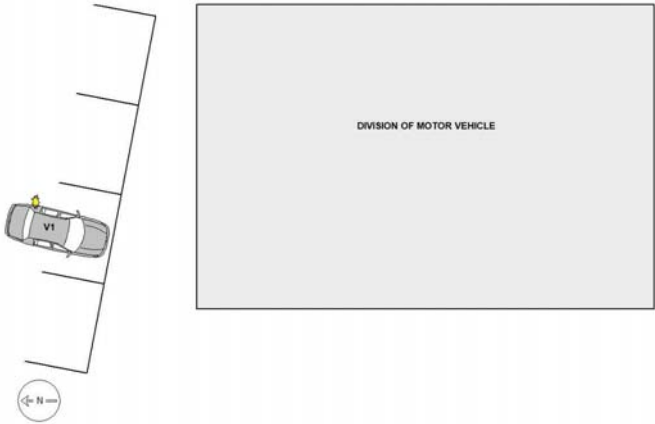
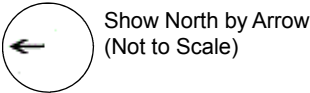

145 Crash Description

THE DRIVER OF V1 STATED IN EFFECT THAT AFTER LEAVING THE MOTOR VEHICLE AGENCY, HE WENT TO OPEN THE DOOR TO V1 AND NOTICED A DENT AND BLACK TRANSFER PAINT ON THE DRIVER SIDE REAR DOOR. HE STATED V1 WAS PARKED AT THE TIME OF THE CRASH AND V2 FLED THE SCENE PRIOR TO POLICE ARRIVAL.

IT SHOULD BE NOTED THAT THERE ARE NO SURVEILLANCE CAMERAS IN THE AREA WHERE V1 WAS PARKED. A SEARCH OF THE IMMEDIATE AREA FOR V2 YIELDED NEGATIVE RESULTS.
