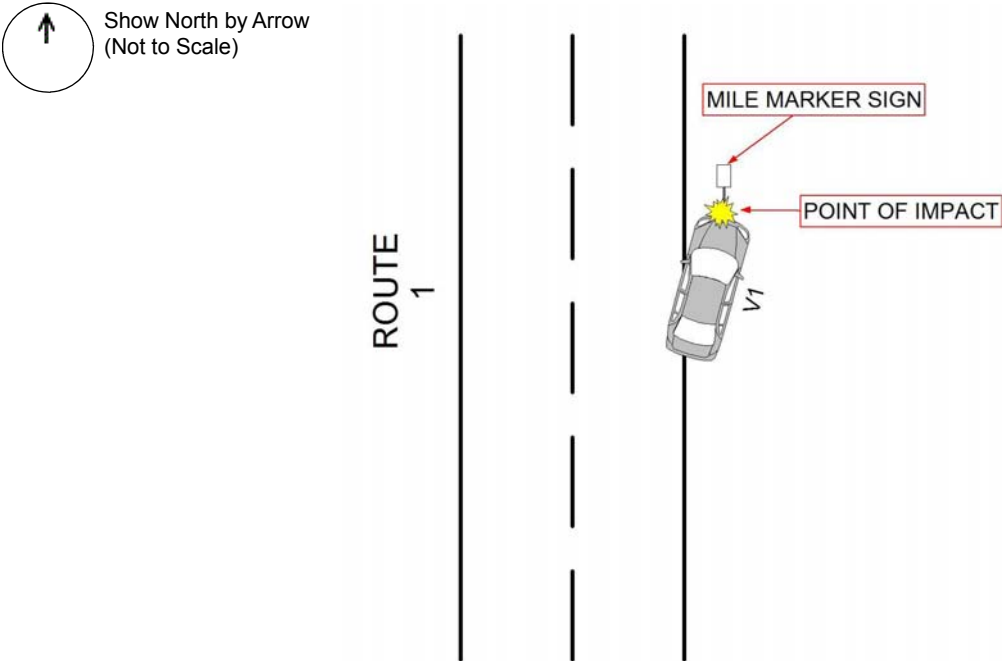

D1 STATED HE WAS DRIVING NORTH ON RT.1 WHEN THE VEHICLE IN FRONT OF HIM SUDDENLY STOPPED. D1 MANEUVERED HIS VEHICLE TO THE RIGHT IN ORDER TO AVOID CONTACT. V1 WENT OVER THE CURB AND STRUCK A MILE MARKER SIGN. D1 WAS NOT INJURED. THE VEHICLE WAS TOWED BY CIRCLE GARAGE.
