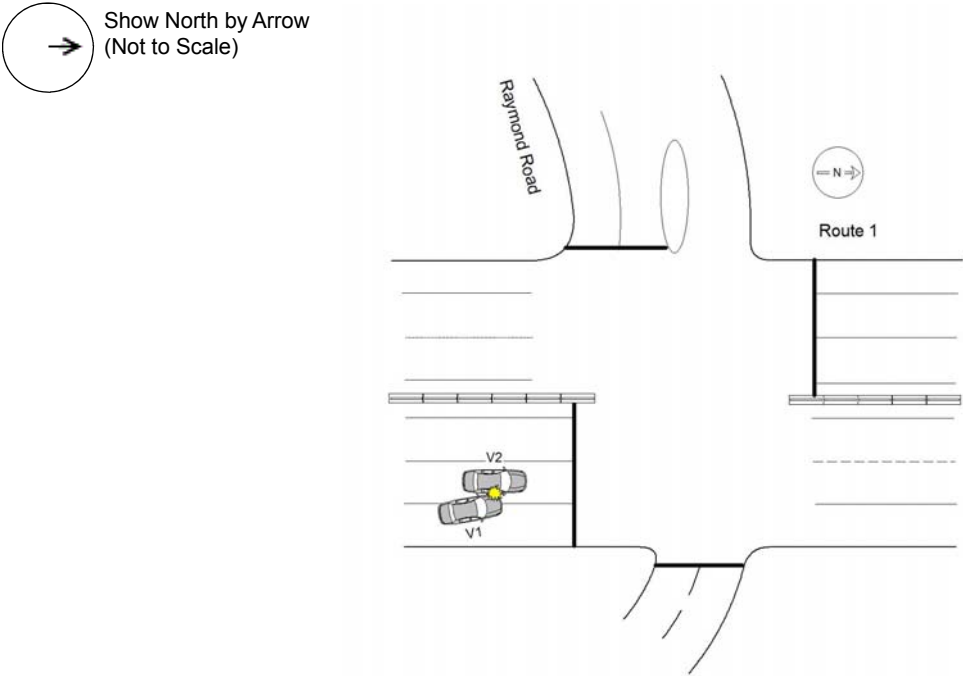

D1 STATED THAT SHE WAS IN THE PROCESS OF MERGING INTO THE CENTER LANE ON ROUTE 1 NORTH BOUND WHEN SHE STATED V2 ALSO WAS MERGING AND CAUSED HER TO SIDE SWIPE V2.
D2 STATED THAT SHE WAS TRAVELING NORTH BOUND ON ROUTE 1 IN THE CENTER LANE WHEN V1 MERGED INTO HER LANE AND SIDE SWIPE HER PASSENGER SIDE. D2 STATED THAT SHE WAS NEVER MERGING.
