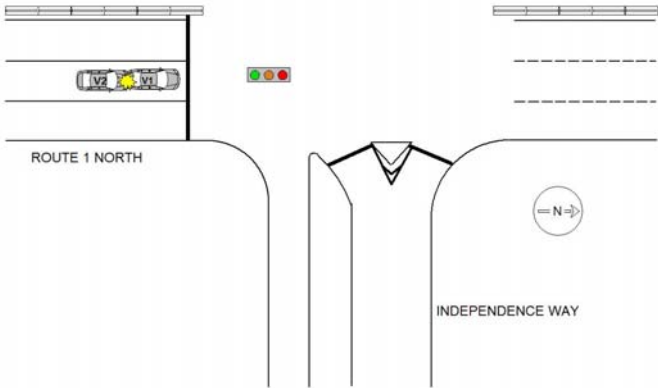

D1 STATED IN EFFECT WHILE STOPPED AT A RED LIGHT ON ROUTE 1, V2 (WHITE JEEP) STRUCK HER FROM BEHIND. V1 SUSTAINED VERY MINOR DAMAGE TO THE REAR BUMPER.

V2 DROVE OFF PRIOR TO POLICE ARRIVAL. SURROUNDING OFFICERS CHECKED ROUTE 1 FOR THAT VEHICLE WITH NEGATIVE RESULTS.

NO INJURIES REPORTED AT THIS TIME.
