

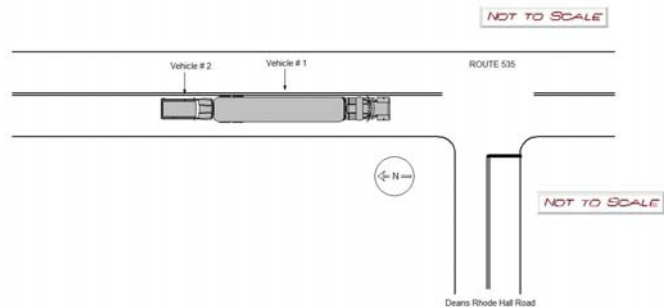

145 Crash Description

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT HE WAS SITTING AT A RED TRAFFIC SIGNAL ON ROUTE 535 SOUTH AT THE INTERSECTION OF DEANS RHODE HALL ROAD. THE VEHICLE IN FRONT OF HIM WASN'T MOVING SO HE BACKED UP IN THE ROADWAY TO GO AROUND HIM AND THEN CONTINUED FORWARD. HE DID NOT KNOW THAT HE CRASHED INTO VEHICLE # 2 WHILE BACKING UNTIL HE WAS NOTIFIED AT HIS PLACE OF EMPLOYMENT AT 10 COSTCO DRIVE IN MONROE TOWNSHIP.

DRIVER OF VEHICLE # 2 STATED IN EFFECT THAT SHE WAS ALSO SITTING AT A RED TRAFFIC SIGNAL ON ROUTE 535 WHEN VEHICLE # 1 WENT INTO REVERSE AND CRASHED INTO HER, HE THEN CONTINUED FORWARD. SHE FOLLOWED HIM TO HIS PLACE OF EMPLOYMENT AT 10 COSTCO DRIVE IN MONROE TOWNSHIP.

OFFICER INVESTIGATION DETERMINED THAT DRIVER OF VEHICLE # 1 WAS AT FAULT FOR THE CRASH.
