145 Crash Description

D1 STATED SHE WAS DRIVING SOUTH ON GEORGES ROAD PRIOR TO THE CRASH. WHILE V1 WAS DRIVING THROUGH THE INTERSECTION OF GEORGES ROAD AND DEANS LANE, V2 IMPACTED THE SIDE OF HER VEHICLE. D2 STATED HE WAS MAKING A LEFT TURN FROM GEORGES ROAD ONTO DEANS LANE, WHEN HIS VEHICLE MADE CONTACT WITH V1.D2 WAS AT FAULT FOR FAILING TO YIELD RIGHT OF WAY. D1 REPORTED INJURIES AND WAS TRANSPORTED TO PRINCETON MEDICAL CENTER.
