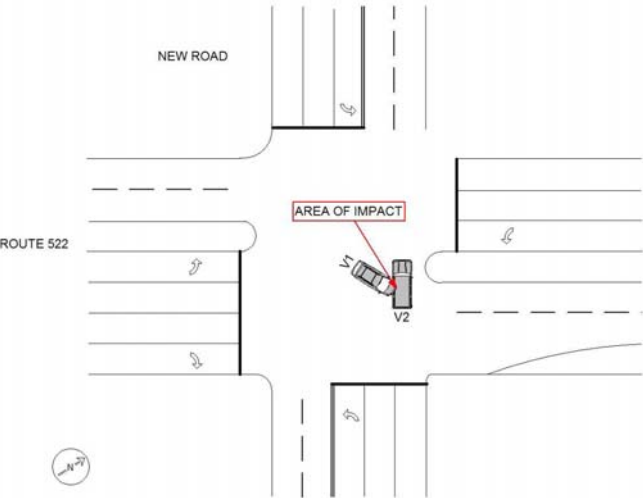
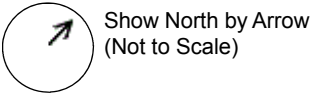

D2 STATED HE WAS TRAVELING ON NEW ROAD PASSING THROUGH THE INTERSECTION OF RT 522. HE STATED AS HE WAS IN THE INTERSECTION, V1 MADE A LEFT TURN FROM NEW ROAD ONTO RT 522 EASTBOUND, AND IMPACTED HIS VEHICLE. D2 STATED AFTER THE IMPACT, V1 FLED THE SCENE. D2 DESCRIBED V1 AS A WHITE TOYOTA SIENNA MINIVAN.

V2 SUSTAINED DAMAGE TO THE DRIVER'S SIDE DOORS, AND DRIVER'S SIDE REAR TIRE. D2 DID NOT REPORT ANY INJURIES. CIRCLE RESPONDED TO THE SCENE AND REMOVED V2.

FURTHER INVESTIGATION REVEALED THE ABOVE INFORMATION FOR V1. THE INVESTIGATION REVEALED V1 WAS STOLEN OUT OF NEW BRUNSWICK. V1 SUSTAINED HEAVY FRONT END DAMAGE, WHICH CORROBORATED D2'S STATEMENT. THE DRIVER OF V1 COULD NOT BE DETERMINED AT THE TIME OF THIS REPORT. MORE INFORMATION CAN BE FOUND UNDER CASE NUMBER I-2020-001876.
