

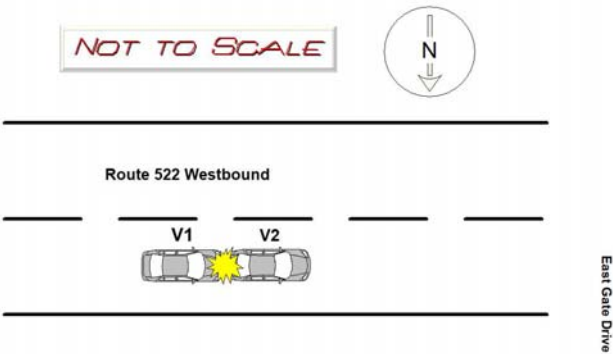

145 Crash Description

D1 STATED, IN EFFECT, THAT HE WAS TRAVELLING WESTBOUND ON ROUTE 522 APPROACHING EAST GATE DRIVE IN THE RIGHT LANE WHEN V2 CAME TO A SUDDEN STOP. D1 FURTHER STATED THAT HE WAS UNABLE TO STOP HIS VEHICLE IN A TIMELY MANNER AND STRUCK V2 IN THE REAR.

D2 STATED, IN EFFECT, THAT SHE WAS TRAVELLING ON ROUTE 522 WESTBOUND IN THE RIGHT LANE WHEN ALL OF A SUDDEN HER VEHICLE WAS STRUCK IN THE REAR BY V1.

NO INJURIES WERE SUSTAINED AT THE SCENE. V1 SUSTAINED MINOR FRONT END DAMAGE. V2 SUSTAINED MINOR REAR END DAMAGE. BOTH VEHICLES WERE DRIVEN AWAY WITHOUT INCIDENT.
