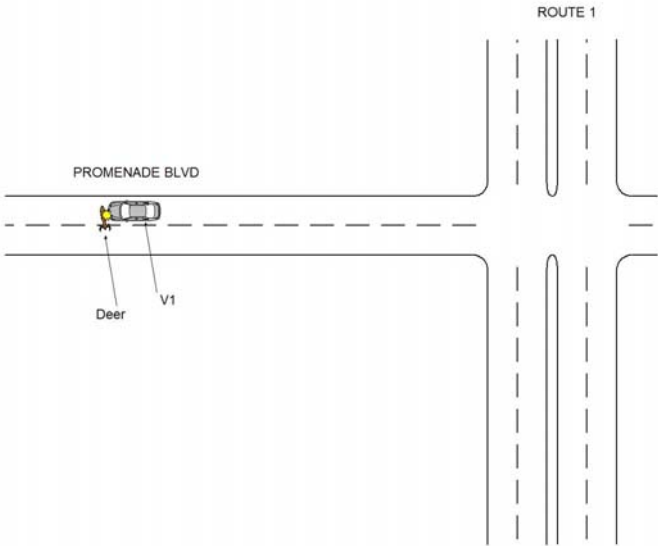
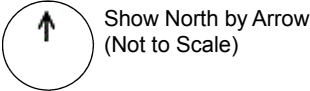

DRIVER 1 STATED IN EFFECT THAT HE WAS TRAVELING WEST ON PROMENADE BLVD WHEN A DEER RAN IN THE ROADWAY. DRIVER 1 STATED THAT HE WAS UNABLE TO STOP BEFORE IMPACTING THE DEER.

NO INJURIES REPORTED. THE FRONT AIRBAG OF VEHICLE 1 WENT OFF. VEHICLE 1 WAS PULLED OFF OF THE ROADWAY AND DRIVER 1 ELECTED TO CALL FOR A PRIVATE TOW.

THE DEER WAS PUT DOWN.
