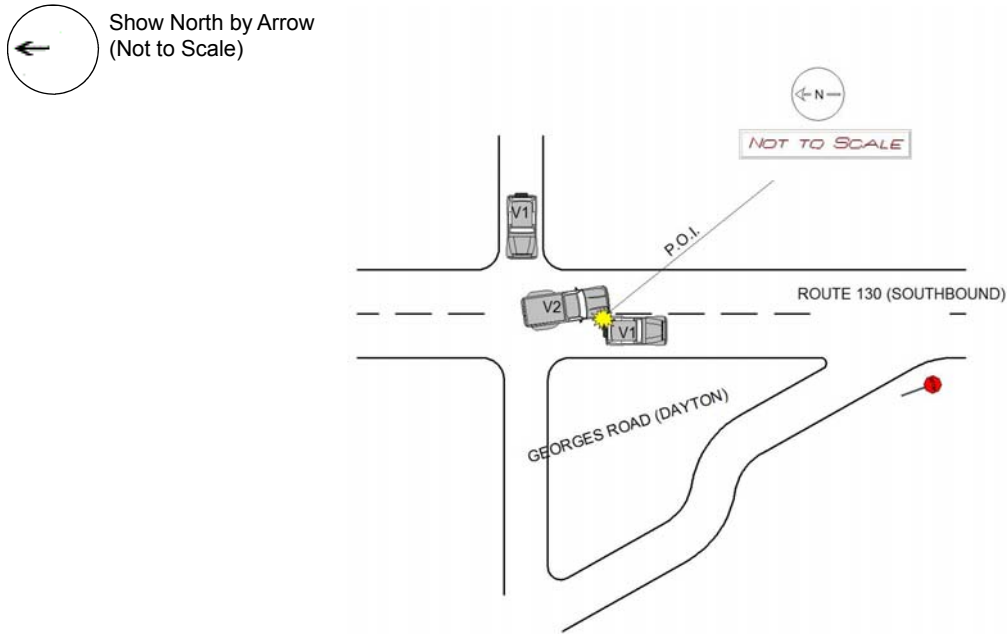

145 Crash Description

DRIVER #1 STATED, HE MADE A U-TURN FROM ROUTE 130 NORTH TO ROUTE 130 SOUTH AND VEHICLE #2 CRASHED INTO HIS BUMPER.

DRIVER #2 STATED, VEHICLE #1 PULLED INTO HIS LANE (ROUTE 130 SOUTH), HE SWERVED IN ATTEMPT TO AVOID THE CRASH BUT FAILED.

WHILE ON SCENE, NO ONE COMPLAINED OF PAIN OR REQUESTED MEDICAL ATTENTION.

I OBSERVED DISABLING DAMAGE TO THE REAR BUMPER AREA AND REAR TIRE OF VEHICLE #1. I OBSERVED MODERATE DAMAGE TO THE PASSENGER SIDE AREA OF VEHICLE #2.

I FOUND DRIVER #1 AT FAULT FOR THE CRASH.
