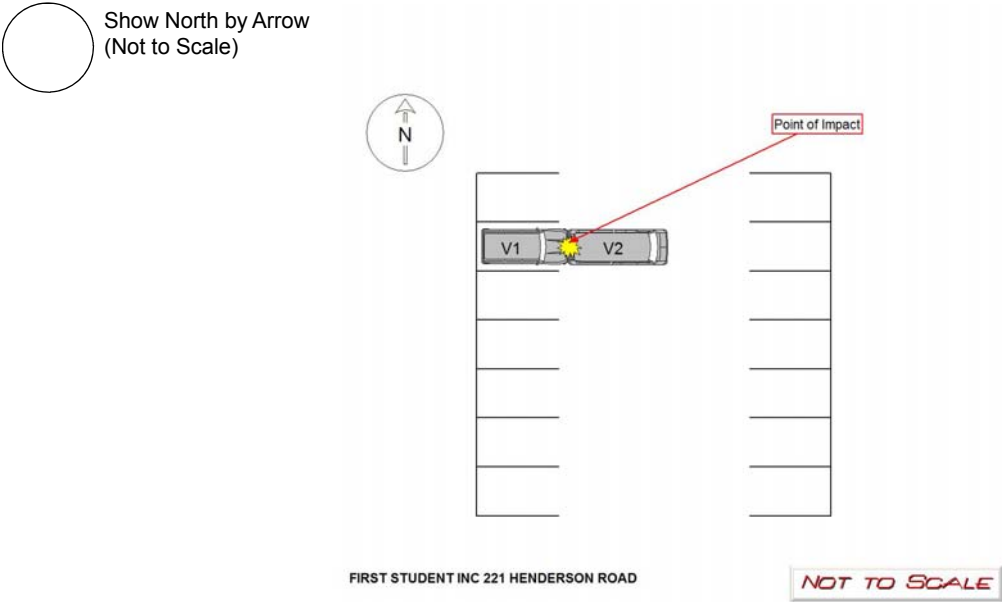

VEHICLE #1 WAS PARKED.
