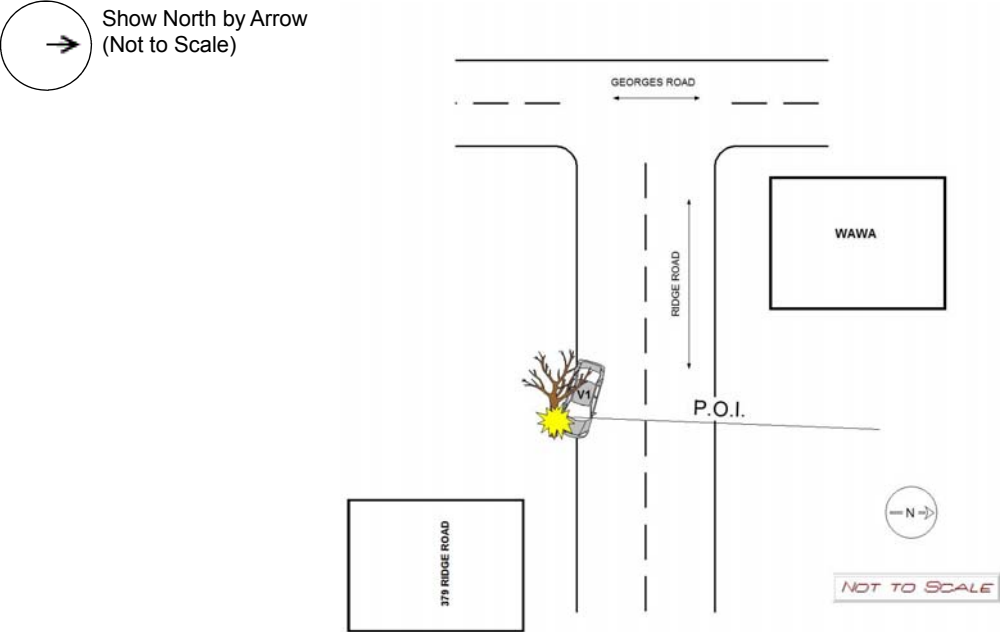

DRIVER #1 STATED, WHILE TRAVELING EAST ON GEORGES ROAD A DEER RAN ACROSS THE ROAD. HE THEN SWERVED TOWARDS THE RIGHT TO AVOID THE DEER AND CRASHED INTO A TREE STUMP.

WHILE ON SCENE, DRIVER #1 DID NOT COMPLAIN OF PAIN OR REQUEST MEDICAL ATTENTION.
