

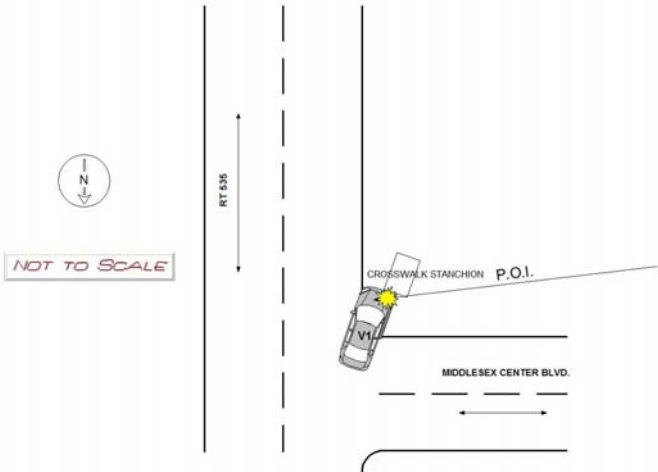

145 Crash Description

DRIVER #1 STATED, WHILE TRAVELING SOUTH ON ROUTE 535 HE TOOK HIS EYES OFF THE ROAD FOR A SECOND AND CRASHED INTO THE CROSSING LIGHT STANCHION.

WHILE ON SCENE, NO ONE COMPLAINED OF PAIN BUT DUE TO AIRBAG DEPLOYMENT EMS WAS REQUESTED AS PRECAUTIONARY. INDIVIDUALS REFUSED MEDICAL ATTENTION.

I OBSERVED FRONT AIRBAG DEPLOYMENT, REAR WINDOW DAMAGE, FRONT BUMPER AND ENGINE AREA, ALONG WITH PASSENGER SIDE MIRROR DAMAGE.

I FOUND DRIVER #1 AT FAULT FOR THE CRASH.
