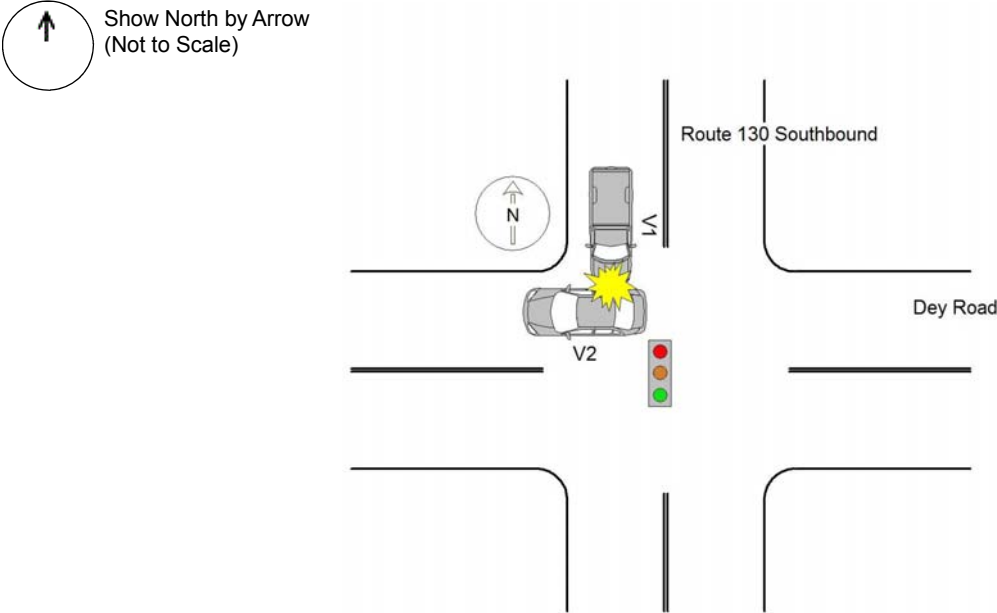

D1 STATED, IN EFFECT, THAT SHE WAS MAKING A RIGHT TURN FROM ROUTE 130 SOUTHBOUND ONTO DEY ROAD WESTBOUND WHEN V2 RAN A RED LIGHT GOING WESTBOUND ON DEY ROAD AND STRUCK HER VEHICLE. D2 STATED, IN EFFECT, THAT HE WAS GOING THROUGH A YELLOW LIGHT ON DEY ROAD WESTBOUND AT THE INTERSECTION WITH ROUTE 130 SOUTHBOUND WHEN V1 INITIATED A RIGHT TURN AND STRUCK HIS VEHICLE. UNABLE TO DETERMINE FAULT DUE TO CONFLICTING STATEMENTS AND LACK OF ROADWAY EVIDENCE. D2 PRODUCED AN INTERNATIONAL DRIVING PERMIT FROM JAPAN (NUMBER LISTED ABOVE). D2 ALSO PRODUCED A SELF-INSURED CARD (NO. XXVI) OUT OF TENNESSEE IN THE NAME OF HERTZ CORPORATION, 255 BRAE BLVD., PARK RIDGE, NJ 07656. D2 RESIDES IN JAPAN FULL TIME BUT WILL BE STAYING AT THE ADDRESS LISTED ABOVE UNTIL JANUARY 18, 2020.
