

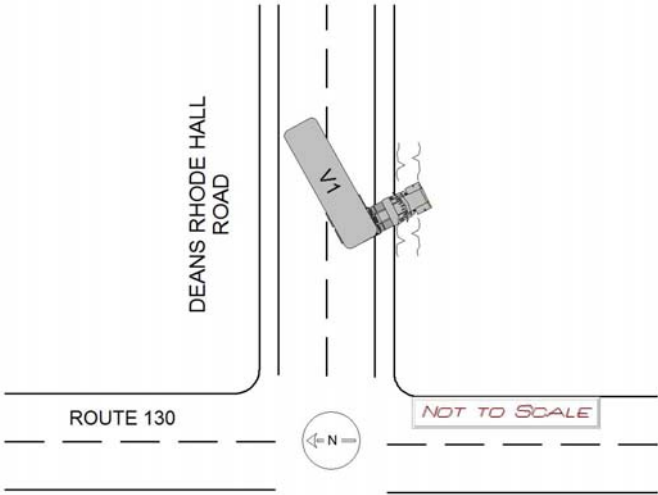

145 Crash Description

DRIVER #1 STATED, IN EFFECT, HE WAS ATTEMPTING TO MAKE A U-TURN WHEN HIS VEHICLE GOT STUCK IN THE MUD. DRIVER #1 FURTHER STATED, HE DID NOT REALIZE THE GROUND WAS WET, AS A RESULT DROVE HIS VEHICLE OVER THE WET LAWN WHERE HIS VEHICLE WAS STUCK. HEAVY DUTY TOW WAS REQUIRED TO REMOVE THE VEHICLE. CIRCLE GARAGE RESPONDED AND REMOVED THE VEHICLE. THERE WAS NO VISIBLE DAMAGE TO VEHICLE #1 AND NO INJURIES WERE REPORTED AT THE SCENE.
