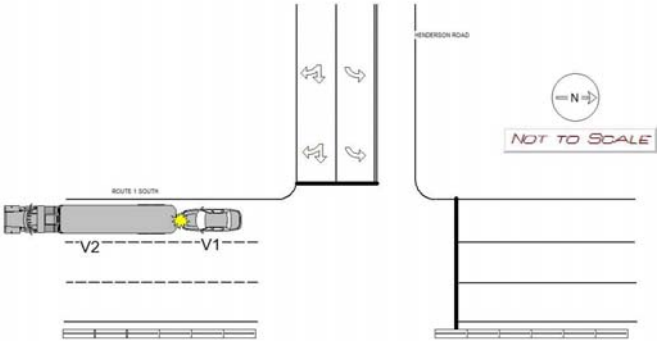
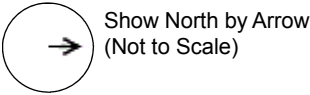

145 Crash Description

DRIVER 1 STATED SHE WAS TRAVELING SOUTH ON ROUTE 1, IN THE RIGHT LANE, WHEN SHE FAILED TO OBSERVE VEHICLE 2 STOPPING IN FRONT OF HER. THEREFORE THE FRONT OF HER VEHICLE COLLIDED WITH THE REAR OF VEHICLE 2.

DRIVER 2 STATED HE WAS TRAVELING SOUTH ON ROUTE 1, IN THE RIGHT LANE, WHEN HE BEGAN TO APPLY HIS BRAKES DUE TO TRAFFIC CONDITIONS. IT WAS AT THIS TIME THAT HE FELT THE IMPACT OF VEHICLE 1 COLLIDING WITH THE REAR OF HIS VEHICLE.

INVESTIGATION DETERMINED DRIVER 1 TO BE AT FAULT FOR FOLLOWING TOO CLOSELY / DRIVER INATTENTION.
