

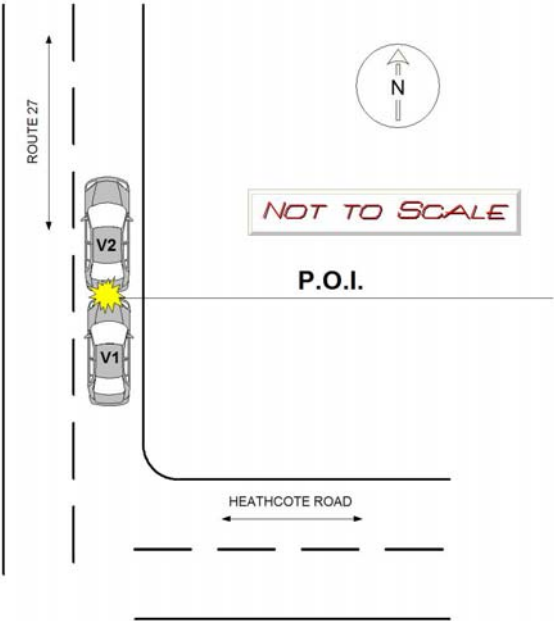

145 Crash Description

DRIVER #1 STATED, WHILE DRIVING ON ROUTE 27 NORTH HE FELT SOMETHING IN HIS EYE AND WHEN HE RUBBED HIS EYE HE CRASHED INTO THE REAR BUMPER OF VEHICLE #2.

DRIVER #2 STATED, WHILE TRAVELING ON ROUTE 27 NORTH VEHICLE #1 CRASHED INTO HIS REAR BUMPER.

WHILE ON SCENE, DRIVER #1 DID NOT COMPLAIN OF PAIN OR REQUEST MEDICAL ATTENTION. DRIVER #2 COMPLAINED OF NECK PAIN BUT REFUSED MEDICAL ATTENTION.

I OBSERVED MINOR DAMAGE TO THE FRONT BUMPER AREA OF VEHICLE #1 AND MINOR DAMAGE TO THE REAR BUMPER AREA OF VEHICLE #2.

I FOUND DRIVER #1 AT FAULT FOR THE CRASH.
