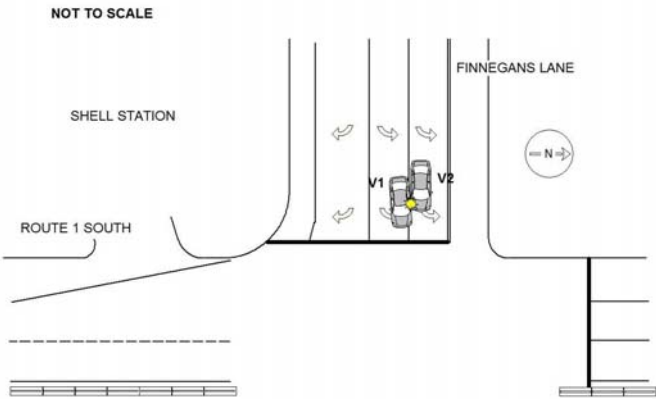

D1 STATED, IN SUMMARY, WHILE TRAVELING ON ABOVE ROADWAY, V2 PASSED HIM ON THE RIGHT AND STRUCK V1. D2 STATED, IN SUMMARY, WHILE TRAVELING ON SAME ROADWAY, V1 ENTERED HIS LANE AND STRUCK V2. INVESTIGATION FOUND THAT V2 WAS IN THE FARTHEST LEFT LANE AND CONTROLLED OWNERSHIP OF THAT LANE WHEN V1 ENTERED FROM THE MIDDLE LANE AND STRUCK V2. NO INJURIES REPORTED.
