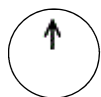


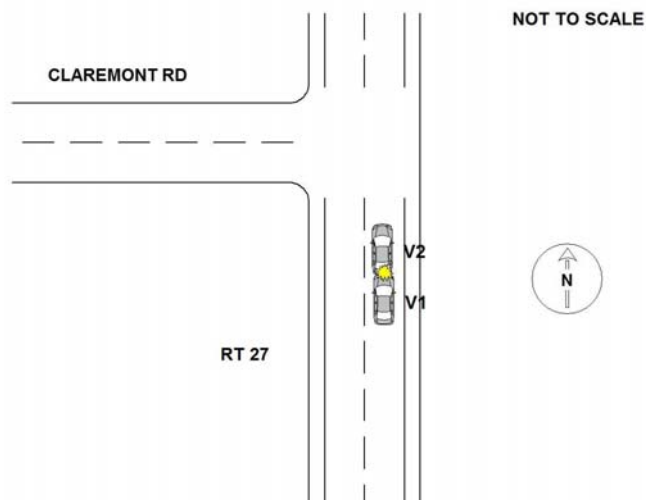

D1 STATED, IN SUMMARY, WHILE TRAVELING ON ABOVE ROADWAY, HE ATTEMPTED TO STOP WITH V2 AHEAD OF HIM BUT COULD NOT STOP IN TIME. V1 THEN REAR-ENDED V2. D2 STATED, IN SUMMARY, WHILE STOPPED AT A RED LIGHT ON SAME ROADWAY, V1 REAR-ENDED V2. D2 HAD A VERY SMALL LACERATION TO HIS NOSE AND LATER COMPLAINED OF BACK PAIN. KPEAS TRANSPORTED D2 FOR TREATMENT. REILLY'S COLLISION RESPONDED TO TOW BOTH VEHICLES.
