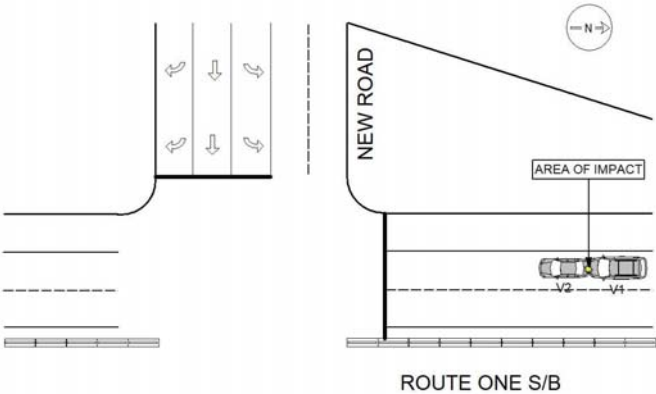

D1 STATED IN EFFECT THAT V1 WAS TRAVELING ON ROUTE 1 SOUTH. D1 FURTHER STATED THAT V1 WAS STOPPING FOR UPCOMING TRAFFIC AND STRUCK THE REAR BUMPER OF V2.

D2 STATED IN EFFECT THAT V2 WAS STOPPED IN TRAFFIC ON ROUTE ONE SOUTH PRIOR TO THE NEW ROAD INTERSECTION.D2 FURTHER STATED THAT V1 STRUCK THE REAR BUMPER OF V2.
