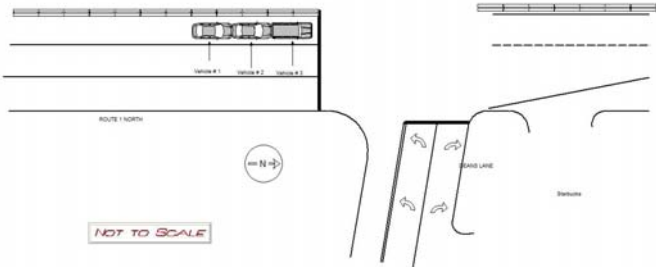

145 Crash Description

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT VEHICLE # 2 STOPPED IN FRONT OF HIM AND HE WAS UNABLE TO STOP BEFORE CRASHING INTO THE REAR OF VEHICLE # 2.

DRIVER OF VEHICLE # 2 STATED IN EFFECT THAT SHE WAS STOPPING FOR A RED TRAFFIC SIGNAL WHEN SHE WAS CRASHED INTO FROM BEHIND BY VEHICLE # 1 WHICH THEN PUSHED HER INTO VEHICLE # 3.

DRIVER OF VEHICLE # 3 STATED IN EFFECT THAT HE WAS STOPPING FOR A RED TRAFFIC SIGNAL, HEARD A LOUD CRASH AND THEN WAS CRASHED INTO FROM BEHIND BY VEHICLE # 2.

OFFICER INVESTIGATION DETERMINED THAT VEHICLE # 1 WAS AT FAULT FOR THE 3 VEHICLE CRASH.
