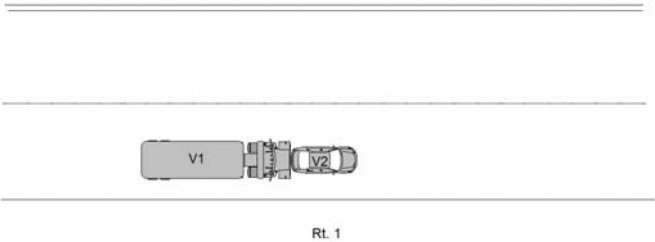

TRAILER REG. NJ TSZ78C

VEHICLE #1 AND VEHICLE #2 WERE IN HEAVY TRAFFIC ON RT. 1 NORTH WHEN VEHICLE #1 STRUCK VEHICLE #2.

DRIVER #1 COULD NOT EXPLAIN WHY HE BUMPED INTO VEHICLE #2.

DRIVER #2 STATED THAT SHE WAS STRUCK FROM BEHIND WHILE IN HEAVY TRAFFIC.

NEITHER PARTY APPEARED INJURED AND BOTH REFUSED MEDICAL TREATMENT.
