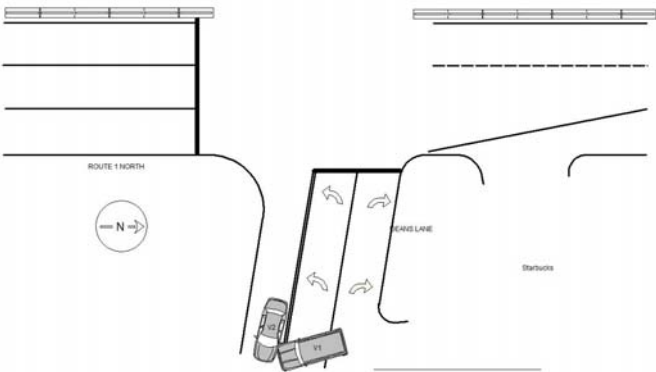

VEHICLE #1 WAS MAKING AN ILLEGAL LEFT TURN FROM THE STARBUCKS PARKING LOT ONTO DEANS LANE EAST WHEN THE VEHICLE STRUCK VEHICLE #2

DRIVER #1 STATED THAT SHE WAS MAKING A LEFT TURN FROM THE STARBUCKS LOT WHEN SHE STRUCK VEHICLE #2.

DRIVER #2 STATED THAT SHE WAS PROCEEDING DOWN DEANS LANE WHEN SHE WAS STRUCK BY VEHICLE #1.

NEITHER PARTY APPEARED INJURED AND BOTH REFUSED MEDICAL ATTENTION..
