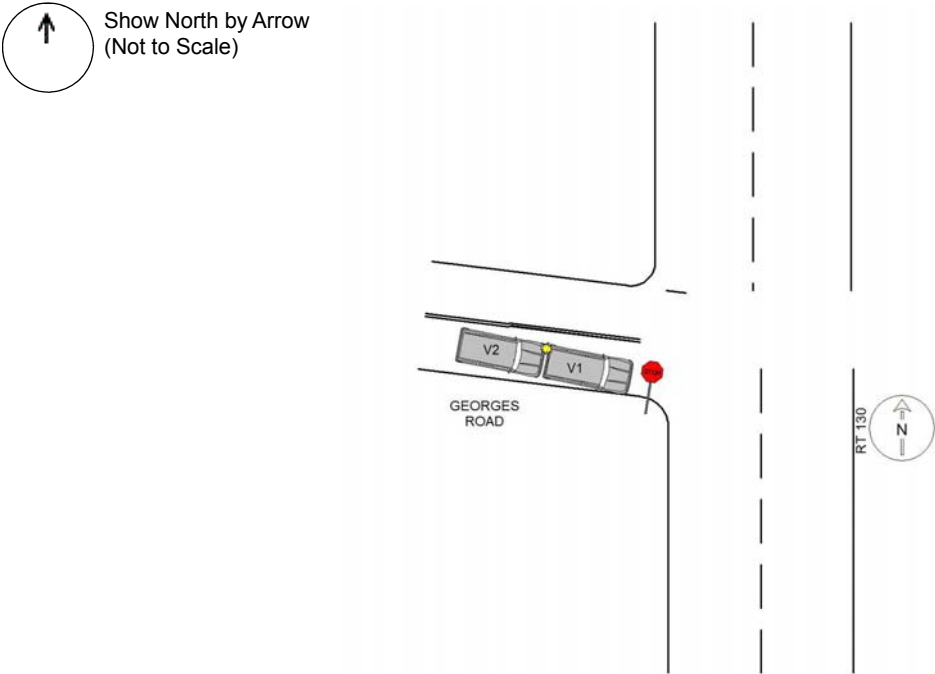

145 Crash Description

D1 STATED IN EFFECT THAT WHILE STOPPED AT THE STOP SIGN ON GEORGES ROAD AND RT 130 SOUTH, V2 IMPACTED V1 CAUSING DAMAGE TO THE DRIVER SIDE REAR BUMPER.

D2 STATED IN EFFECT THAT WHILE WAITING IN TRAFFIC BEHIND V1 AT THE STOPPED SIGN ON GEORGES ROAD AND RT 130 SOUTH, D1 ACCELERATED THEN CAME TO COMPLETE STOP IN FRONT OF HER. D2 STATED SHE TRIED TO AVOID STRIKING V1 BY STEERING TO THE LEFT, BUT WAS UNSUCCESSFUL.
