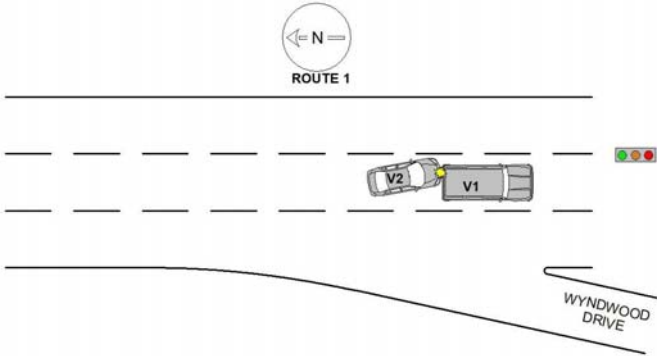

D1 STATED IN EFFECT THAT WHILE TRAVELING SOUTH ON ROUTE 1 NEAR WYNDWOOD DRIVE, HE SLOWED DOWN FOR TRAFFIC AT WHICH TIME V2 IMPACTED THE REAR BUMPER OF V1.

D2 STATED IN EFFECT THAT WHILE TRAVELING SOUTH ON ROUTE 1 NEAR WYNDWOD DRIVE, V1 CAME TO A COMPLETE STOP IN FRONT OF HIM. D2 STATED HE STEERED TO THE LEFT TO AVOID STRIKING V1 BUT WAS UNSUCCESSFUL.
