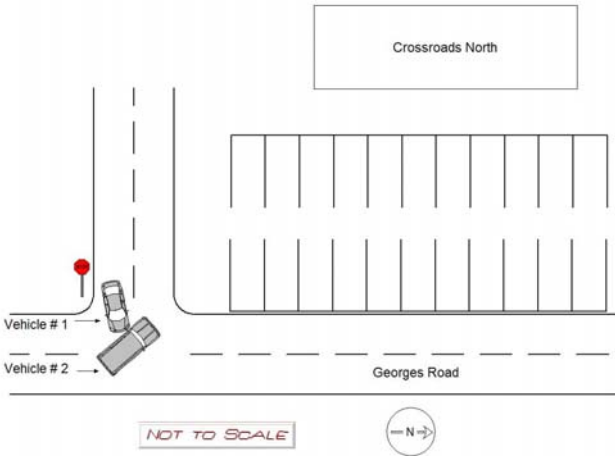

DRIVER OF VEHICLE # 1 STATED IN EFFECT THAT HE WAS TURNING LEFT OUT OF THE SCHOOL PARKING LOT ONTO GEORGES ROAD AND DIDN'T SEE VEHICLE # 2 APPROACHING.

DRIVER OF VEHICLE # 2 STATED IN EFFECT THAT HE WAS MAKING A LEFT TURN FROM GEORGES ROAD INTO THE SCHOOL PARKING LOT WHEN VEHICLE # 1 EXITED THE SCHOOL AND CRASHED INTO HIS DRIVERS SIDE DOOR.

OFFICER INVESTIGATION DETERMINED THAT VEHICLE # 1 WAS AT FAULT FOR THE CRASH.
