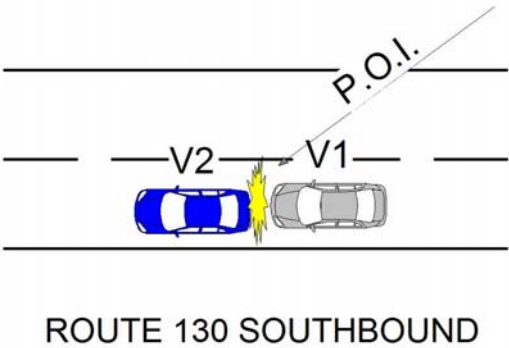

D1 STATED WHILE TRAVELING SOUTHBOUND ON ROUTE 130 NEAR FRIENDSHIP ROAD, HE CRASHED THE FRONT BUMPER OF V1 INTO THE REAR BUMPER OF V2.

D2 STATED WHILE STOPPED AT THE RED TRAFFIC LIGHT ON ROUTE 130 SOUTH NEAR FRIENDSHIP ROAD, D1 CRASHED THE FRONT BUMPER OF V1 INTO THE REAR BUMPER OF V2.

WHILE ON SCENE, NO ONE COMPLAINED OF PAIN OR REQUESTED MEDICAL ATTENTION. WHILE ON SCENE, I OBSERVED DAMAGE TO THE FRONT BUMPER OF V1 AND DAMAGE TO THE REAR BUMPER OF V2.

D1 IS AT FAULT FOR THE CRASH.
