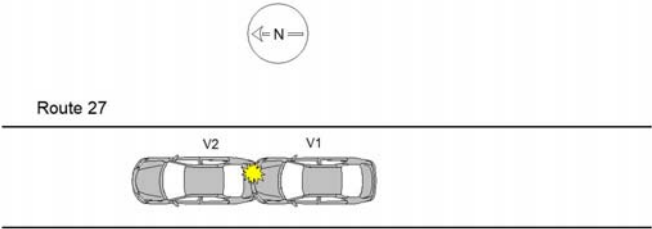
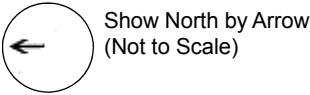

D1 STATED THAT WHILE TRAVELING NORTH ON ROUTE 27 SHE DID NOT SEE V2 STOP AND REAR ENDED V2. D2 STATED THAT WHILE ON ROUTE 27 SHE WAS STOPPING TO TURN AND WAS REAR ENDED. D1 IS AT FAULT FOR THE CRASH. D1 COMPLAINED OF BACK PAIN BUT REFUSED A SQUAD.
