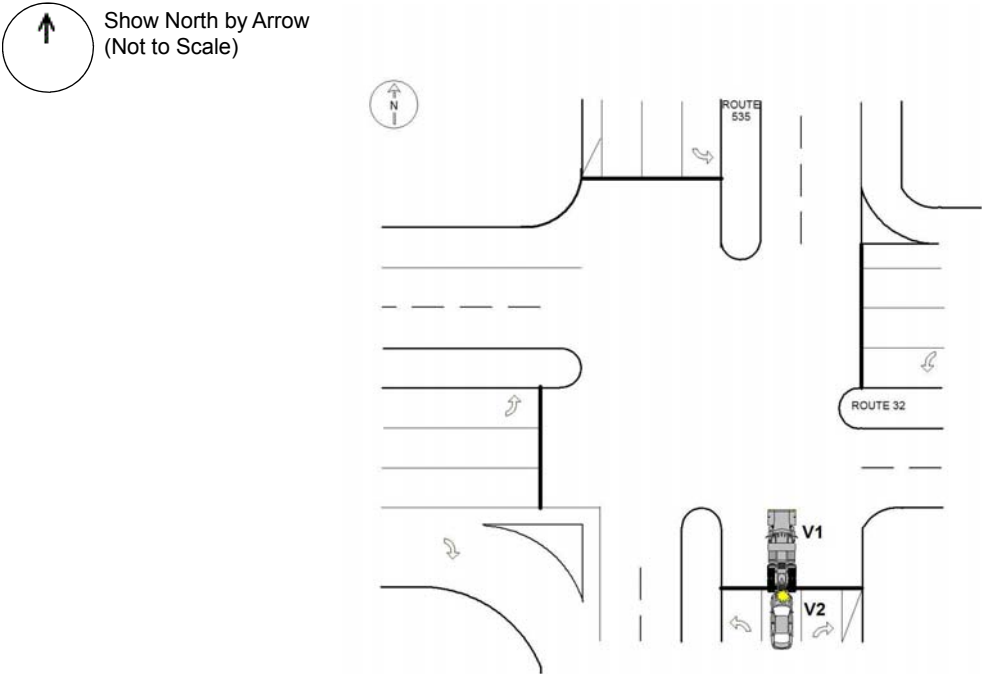

D1 STATED IN SUMMARY HE WAS TRAVELING NORTH ON RT 535 AT THE INTERSECTION OF RT 32 WHEN THE LIGHT BEGAN TO CHANGE FROM GREEN TO AMBER AND THEN RED. HE STATED DUE TO HEAVY TRAFFIC HIS VEHICLE WAS PARTIALLY IN THE INTERSECTION SO HE BACKED UP SLOWLY TO CLEAR THE INTERSECTION AND WAS UNAWARE HE STRUCK V2.

D2 STATED IN SUMMARY SHE WAS TRAVELING NORTH ON RT 535 AT THE INTERSECTION OF RT 32 WHEN V1 WHICH WAS STOPPED IN FRONT OF HER BEGAN TO ROLL BACK AND THEN STRUCK HER VEHICLE. SHE STATED V1 CONTINUED NORTH ON RT 535 UNTIL IT WAS STOPPED BY POLICE PRIOR TO RIDGE ROAD AND RT 535.
