

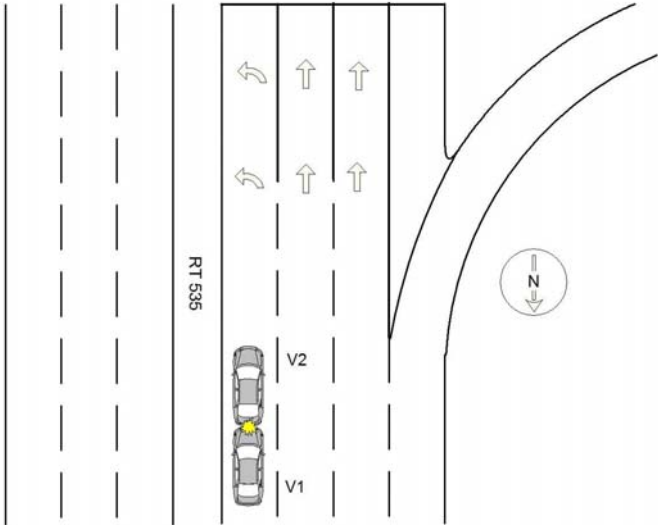

D1 STATED IN SUMMARY SHE WAS TRAVELING SOUTH ON RT 535 PRIOR TO RT 32 WHEN SHE WAS UNABLE TO STOP HER VEHICLE IN TIME PRIOR TO IMPACTING V2 IN THE REAR.

D2 STATED IN SUMMARY HE WAS STOPPED IN TRAFFIC IN THE LEFT TURN LANE OF RT 535 SOUTH PRIOR TO RT 32 WHEN HIS VEHICLE WAS IMPACTED IN THE REAR BY V1.
