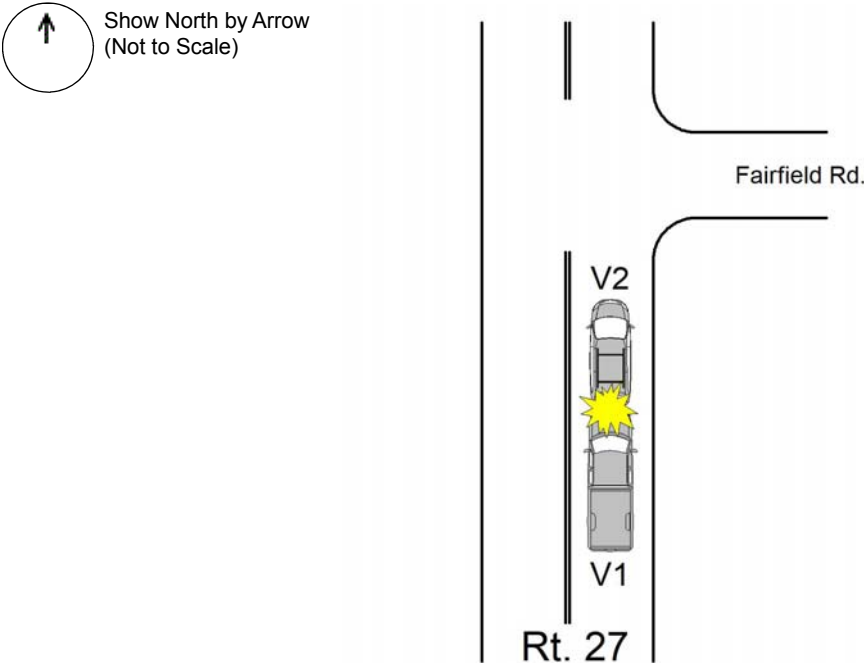

V2 WAS SLOWING FOR TRAFFIC WHEN V1 COLLIDED WITH THE REAR OF HER VEHICLE. D1 STATED THAT HE WAS LOOKING DOWN TO PICK SOMETHING UP THAT FELL FROM HIS DASH, WHEN HE LOOKED UP, V2 HAD STOPPED. HE WAS UNABLE TO STOP IN TIME AND MADE CONTACT WITH THE REAR OF V2. THERE WERE NO REPORTED INJURIES ON SCENE.
