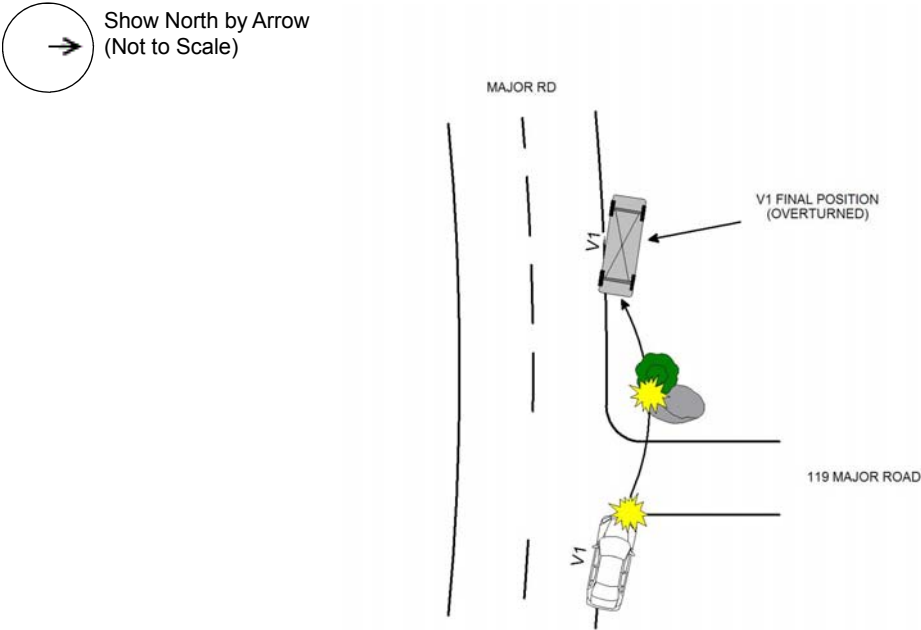

145 Crash Description

D1 STATED AS HE WAS TRAVELLING ON MAJOR ROAD A DEER RAN ACROSS THE ROADWAY. D1 VEERED HIS VEHICLE IN AN ATTEMPT TO AVOID A COLLISION WITH THE DEER BUT SUBSEQUENTLY RAN OFF THE ROAD WAY TO THE RIGHT. D1'S VEHICLE THEN CROSSED OVER THE DRIVEWAY OF 119 MAJOR ROAD AND COLLIDED WITH LANDSCAPING. D1'S VEHICLE CONTINUED ON THE FRONT PROPERTY OF 119 MAJOR UNTIL THE VEHICLE ULTIMATELY CAME TO A STOP AFTER OVERTURNING. THE DRIVER COMPLAINED OF CHEST PAIN BUT REFUSED MEDICAL ATTENTION. V1 WAS TOWED FROM THE SCENE WITHOUT ISSUE.
