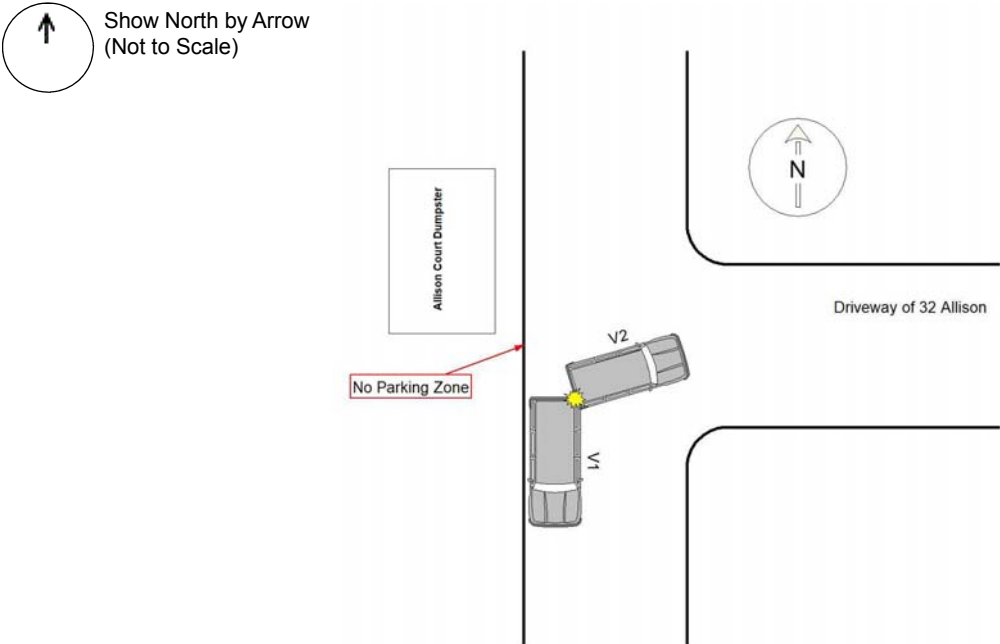

D2 STATED, IN EFFECT, THAT WHILE BACKING OUT OF HIS DRIVEWAY HE DID NOT OBSERVE V1 ON THE OPPOSITE CURB AND HE STRUCK THE REAR DRIVERS SIDE BUMPER CAUSING MINOR DAMAGE. V1 WAS UNOCCUPIED AND PARKED IN A CLEARLY MARKED "NO PARKING ZONE" WITHIN THE DEVELOPMENT. THE OWNER OF V1 WAS LOCATED AND MOVED THE VEHICLE. MINOR DAMAGE TO BOTH VEHICLES. NO TOWS OR INJURIES.
