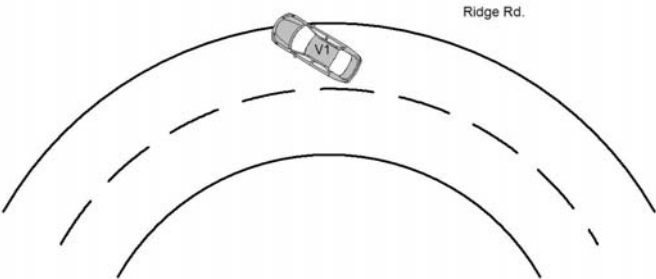
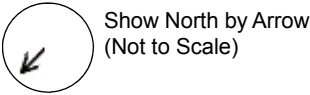

VEHICLE #1 WAS HEADED EAST ON RIDGE RD., APPROACHING MONMOUTH JCT., WHEN IT SLID ON AN ICE PATCH AND STRUCK THE CURB. IT WAS SNOWING AT THE TIME OF THE CRASH.

DRIVER #1 STATED THAT HE LOST CONTROL OF THE VEHICLE AS HE ENTERED THE TURN DUE TO THE ICE.

DRIVER #1 APPEARED UNINJURED AND REFUSED MEDICAL ASSISTANCE.
