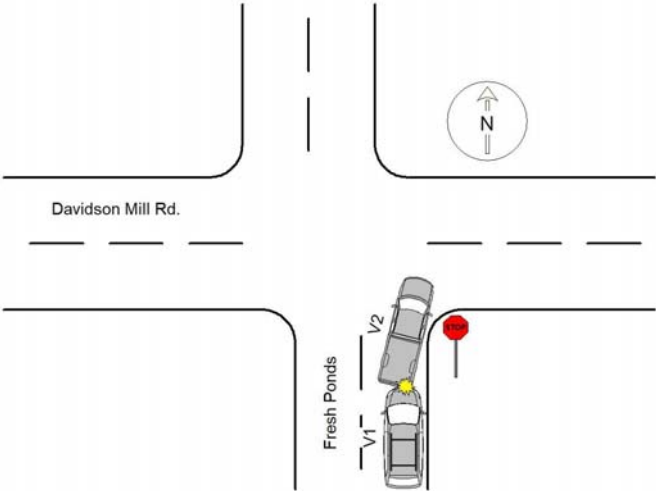

145 Crash Description

D1 STATED, IN EFFECT, THAT WHILE ATTEMPTING TO STOP AT THE ABOVE INTERSECTION HE SLID ON ICE AND STRUCK THE REAR OF V2 WHICH WAS STOPPED. D2 STATED THAT WHILE HE WAS STOPPED AND WAITING TO MAKE A RIGHT TURN ONTO DAVIDSON MILL ROAD HIS VEHICLE WAS STRUCK FROM THE REAR BY V1. MINOR DAMAGE SUSTAINED TO BOTH VEHICLES AND NO INJURIES WERE REPORTED.
