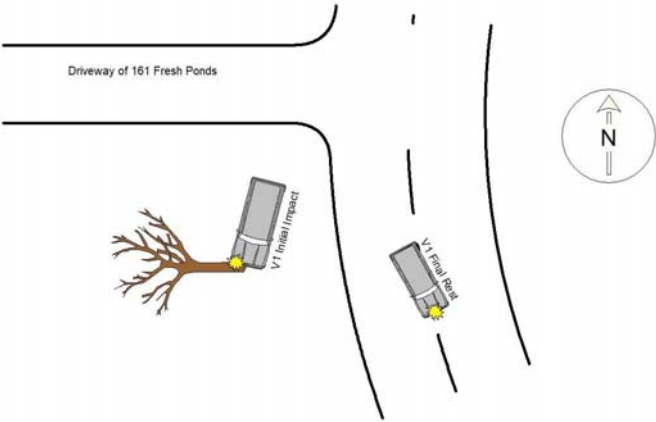
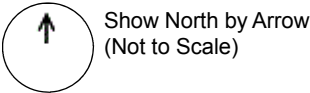

D1 STATED, IN EFFECT, THAT WHILE COMING AROUND THE BEND ON FRESH PONDS ROAD HE LOST CONTROL OF HIS VEHICLE DUE TO THE ICY ROAD CONDITIONS AND STRUCK A TREE IN THE FRONT YARD OF 161 FRESH PONDS ROAD. V1 SUSTAINED HEAVY DAMAGE AND WAS TOWED BY GEORGES GARAGE. D1 COMPLAINED OF FACIAL AND LEG PAIN AND WAS LATER TRANSPORTED TO RWJ. NO FURTHER.
