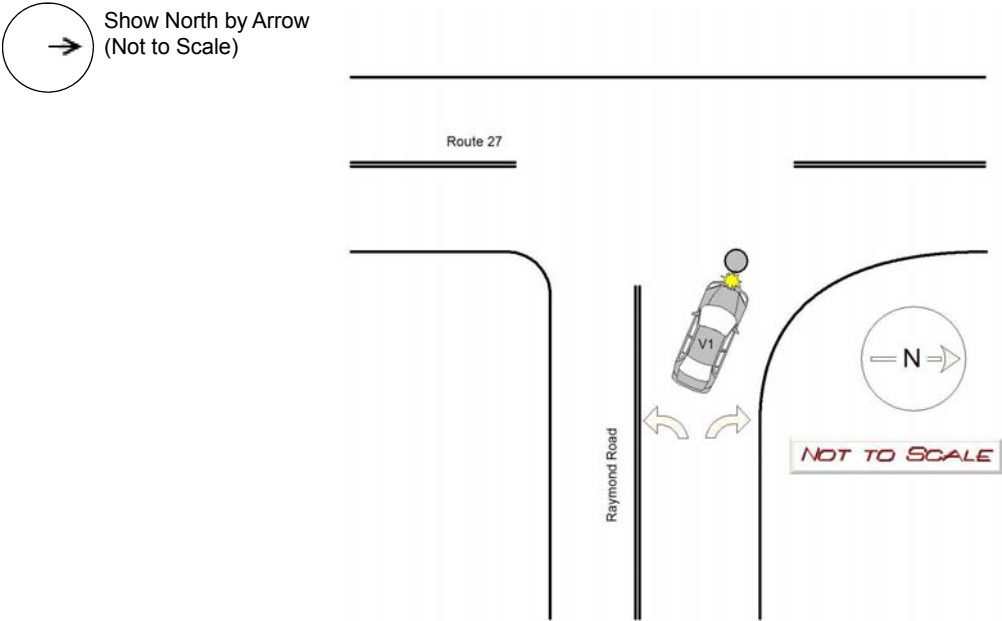

145 Crash Description

DRIVER #1 STATED IN EFFECT WHILE SLOWING FOR A RED TRAFFIC SIGNAL, VEHICLE #1 WAS SLIDING DUE TO ICY CONDITIONS AND DRIVER #1 DID NOT HAVE CONTROL OF THE VEHICLE. VEHICLE #1 THEN STRUCK A TELEPHONE POLE INSTEAD OF THE VEHICLE IN FRONT OF HIM. NOTE THE TELEPHONE POLE IS ON AN ISLAND BETWEEN RAYMOND ROAD AND ROUTE 27.

TELEPHONE POLE #61047SB WAS NOT DAMAGED FROM THIS INCIDENT. PSE&G AND VERIZON WERE NOTIFIED AND DID NOT WISH TO RESPOND OUT.
