

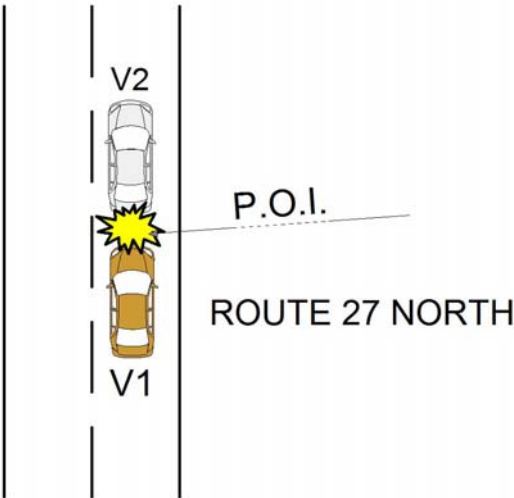

D1 STATED WHILE TRAVELING NORTHBOUND ON ROUTE 27 NEAR FINNEGANS LANE, SHE DID NOT STOP IN TIME AND CRASHED THE FRONT BUMPER OF V1 INTO THE REAR BUMPER OF V2.

D2 STATED WHILE STOPPED AT A RED TRAFFIC SIGNAL ON ROUTE 27 NEAR FINNEGANS LANE, D1 CRASHED THE FRONT BUMPER OF V1 INTO THE REAR BUMPER OF V2.

WHILE ON SCENE, NO ONE COMPLAINED OF PAIN OR REQUESTED MEDICAL ATTENTION. WHILE ON SCENE, I OBSERVED DAMAGE TO THE FRONT BUMPER OF V1 AND DAMAGE TO THE REAR BUMPER OF V2.
