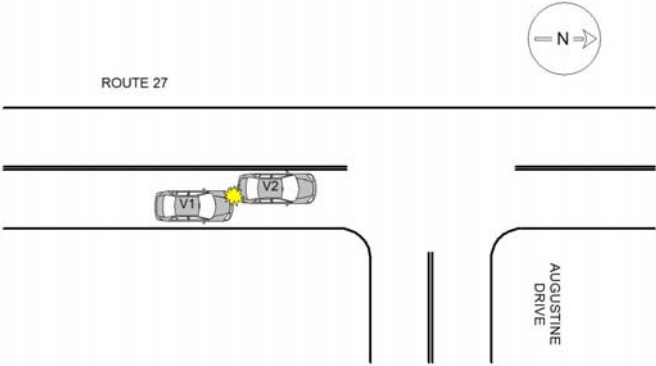
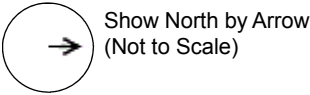

DRIVER 2 STATED IN EFFECT THAT SHE WAS STOPPED ON ROUTE 27 NORTHBOUND WITH HER LEFT TURN SIGNAL ON, WAITING FOR THE SOUTHBOUND TRAFFIC TO CLEAR WHEN SHE FELT VEHICLE 1 IMPACT THE REAR OF HER VEHICLE.

DRIVER 1 STATED IN EFFECT THAT HE WAS TRAVELING NORTHBOUND ON ROUTE 27 AND OBSERVED VEHICLE 2 STOPPED AHEAD OF HIM WITH HER LEFT TURN SIGNAL ON. DRIVER 1 THEN STATED THAT HE ATTEMPTED TO GO AROUND VEHICLE 2 AND IN DOING SO HE IMPACTED THE REAR OF VEHICLE 2.
