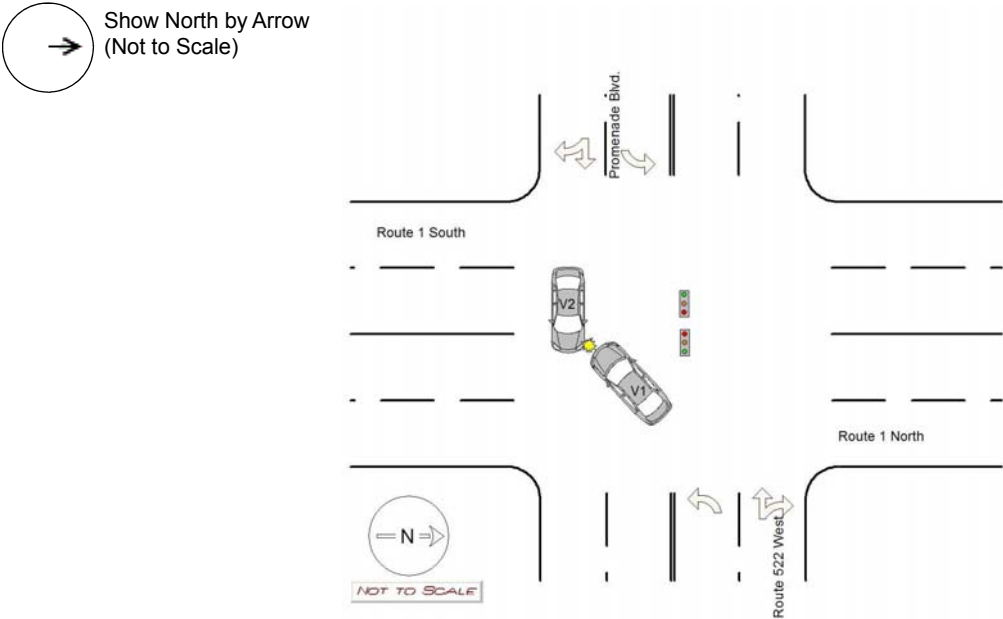

DRIVER #1 STATED IN EFFECT WHILE MAKING A LEFT TURN ONTO ROUTE 1 SOUTH, VEHICLE #1 STRUCK VEHICLE #2 DUE TO NOT SEEING VEHICLE #2.

DRIVER #2 STATED IN EFFECT WHILE TRAVELLING EAST FROM PROMENADE BLVD. ACROSS THE INTERSECTION OF ROUTE 1, VEHICLE #1 STRUCK VEHICLE #2.

DRIVER #1 IS AT FAULT FOR MAKING A LEFT TURN WITHOUT THE PASSAGE BEING CLEAR.

DRIVER #2 WAS TRANSPORTED TO PRINCETON MEDICAL CENTER VIA EMS FOR COMPLAINT OF KNEE AND LEG PAIN.
